Message from the Leadership Team

Happy November! We've passed through the colourful fall celebrations. Now it's full speed ahead to Christmas! I hope everyone will be able to join us for our Holiday Potluck Dinner. This year, Patti has generously agreed to open her home for this festive occasion on Tuesday, December 12th. I enjoyed this event very much last year as I was new to the club, and was able to meet and chat with many different women and the food was excellent! I look forward to seeing you there! This year, we currently have four initiatives on the go. Barb and Lynne are collecting money for the Basketeers initiative. They will then go on a fun shopping trip to Home Hardware, who has proven to be very supportive in the past. The filled baskets are then given to women leaving Nova Vita, Ganohkwasra or Ojistoh House, as they set up their new homes and transition into violence free lives.

Two of our initiatives are new this year. Colette proposed that we nominate "Kids Can Fly Brantford" for the CFUW Library Award. This \$4000 grant was created to promote literacy and learning by supporting innovative approaches, encouraging community involvement and advocating for the Canadian library system. "Kids Can Fly Brantford" is a registered charity that supports early child development and parenting, and raises money and public awareness about the importance of early learning and parenting. Some of their programs include "Roots of Empathy" (an anti-bullying program within elementary schools), "Launch Pad" (an early learning and parenting centre), "Parachute Program" (for mothers facing challenges after birth), "Imagination Library" (a program that promotes early literacy). The winner of this award will be chosen and announced in 2018.

Our second new initiative is a book launch. Marsha's book "Don't Tell the Enemy" is to be published on December 26th. CFUW Brantford will be hosting the Brantford launch of this book early in the New Year. The book is based on a true story of a mother and daughter who hid three Jewish friends under their kitchen floor during the Holocaust. At the launch, Marsha will talk about her book, sign copies and answer questions. She will donate \$2.70 from each book sold to CFUW Brantford. A committee is currently at work securing a venue for this event. Stay tuned for more details.

Our final initiative is Trivia Night. Lynn, Brenda, Dian and Colette are busy planning this fun-filled event. While the main aim is to raise money for the Scholarship Fund, it is also an enjoyable social evening and raises the profile of CFUW locally. Start putting your team together and mark your calendars for February 14th, 2018.

At October's General Meeting, we heard from a very dynamic speaker, Jodie-Lynn Waddilove, a lawyer who has served as legal counsel for the Ministry of the Attorney General for ten years and is presently serving as Senior Legal Counsel on the Independent Street Checks Review with Justice Tulloch. Her talk, entitled "Indigenous Peoples in Ontario and Canada: A discussion about historical and contemporary issues from an Anishinaabe Woman's perspective" took us through various topics including understanding of terminology such as Aboriginal, First Nations, etc., Aboriginal cultures in Ontario, and issues facing Aboriginal cultures today. She spoke of her early life on the reserve, the difficulties of education for indigenous children, what it means to be a "Status Indian", the Indian Act, the Truth and Reconciliation Commission, and media bias. She ended with the message that "we need to be uncomfortable if we're going to have real conversations and make a change". In her thank you, Mieke admitted that while we were uncomfortable, she had left us with the challenge to continue to ask "why is that?".

Nationally, CFUW has recently joined IAW. The International Alliance of Women is an international NGO with 41 member organizations, involved in the promotion of women's human rights, equality and the empowerment of women.

There continues to be controversy about GWI. For further information about this, please read Betsy's article. In ending this month, the leadership team would like to thank you all for your support this fall, as we learned the ropes and adjusted to our new roles within CFUW Brantford.

News from National

GWI dues increase update:

CFUW has sent out a FAQ sheet respecting the GWI dues increase and issues arising out of same. The information can be obtained in its entirety on the CFUW National website. CFUW also released the outcome of the survey. I have summarized the two documents below.

The survey results were to aid the delegates as to how local clubs wanted the National delegates to vote at the 32nd General Assembly which took place on October 23 & 24, 2017. The vote was electronic and the outcome was not known as of the draft-ing of this article but may be known as of the date of this publication.

Question 1: The motion being tabled was for an increase in two installments over the first two years being paid – \$20.70 (the current fee) paid on January 1, 2018 and 2019 with the remaining \$8.40 due by June 30. This was supported by 56% and not approved by 44%. As a result of the survey National delegates will be voting to support an increase in keeping with this motion. With this option, fee's will increase yearly in accordance to the country's Gross National Income and Human Development Index as calculated on July 1 of each year;

Question 2: Do you support any per capita dues increase? 57 % did not approve while 43% voted to approve.

Question 3: This is the original fee increase which is an increase of dues over a 3 year period from 2017 to 2019 to \$48.30 CDN. This is the original fee increase and will stand if the motion (as set out in option 1) does not /did not pass. 73% voted to not approve with just 275 voting to approve.

Any increase will take effect until 2019-2010 fiscal year .The next AGM is in June 2018 -- to amend or remove the GWI clause from the Bylaws of GFUW National a Notice of Motion must be sent to Clubs at least 120 days in advance of the AGM. Also, GWI still not agreeing to a full forensic audit: instead agreeing to a "voluntary limited statutory audit" (whatever that is).

Resolutions passed at the 2017 AGM:

There were two resolutions passed: 1. The Right to Safe, Clean, Accessible and Affordable Drinking Water and Sanitation on First Nations Reserves in Canada; and 2. Universal Pharmacare.

Excursions:

The Waterloo Regional Museum has an exhibit running until January 7, 2018: "Trailblazing- Women in Canada since 1867". Activism:

Starting November 25, 2017 (The International Day for the Elimination of Violence Against Women) to December 10, 2017 (International Human Right's Day) is the 16 Days of Activism against Gender-based Violence Campaign. In the middle, on December 6, 2017, is the National Day of Remembrance and Action on Violence against Women.

National has started a new project related to Sexual Assault on Campus and continues with its Child Care Campaign. Should you wish to learn more about these projects and campaigns please access the National website.

News from National –addendum

Since News from National was drafted there has been a flurry of activity, and a brief update is as follows:

1. The results of the 32nd General Assembly electronic vote have been received. The motion (as set out in Question 1) was passed, as was the budget and change of auditor motion.

2. A Lawyers Letter was sent by CFUW to GWI which set out the following:

a. The vote was unconstitutional due to the electronic voting method used and the lack of debate. The letter indicates that the process in the Constitution of GWI was not followed;

b. CFUW in its letter to GWI indicates that the proposed, limited audit of GWI is unconstitutional and would require the amendment of the constitution which sets out a more extensive audit requirement. CFUW requested various financial disclosures be made by GWI & it proceed with a proper audit.

3. A Lawyers opinion was received by CFUW about its fiduciary obligations related to the GWI fee increase. In a nut shell it indicates that while a member of GWI it must abide by its obligations to GWI, including forwarding dues collected for GWI. However, CFUW cannot place the financial stability of CFUW at risk. Therefore, if the GWI fee increase cannot be collected by CFUW (i.e. not passed at the annual meeting or clubs simply refuse to pay that portion of the fee) CFUW cannot pay out of its own funds if such action places the financial health of CFUW at risk.

News from Regional

The e-newsletter from Ontario Council, Dates & Data, has expanded its mail out capabilities. In the past they were limited to sending out this newsletter (sent out 6 times annually) to club presidents and asking it to be forwarded. It is now being made available to all members.
