# Summary of CFUW National Virtual AGM held June 25 & 26, 2021

The AGM was attended by Lin F. and Betsy C. Lin attended on the June 25<sup>th</sup> date and Betsy on the June 26<sup>th</sup> date, which was solely for resolutions.

One interesting topic of discussion post AGM is whether the virtual format allows for greater democracy, as clubs that cannot attend in person are offered the opportunity to participate, via virtual attendance, as opposed to sending a proxy. So interesting issues are arising out of the virtual experience that was thrust on all of us due to COVID.

#### Resolutions:

The following sets out the resolutions as adopted at the AGM. Please note that some of the resolutions are quite different in their final form as presented at the AGM, from the initial form, which was discussed by the club. All the resolutions were passed by a healthy margin. There was not much discussion about the resolutions, perhaps because of the virtual context, or because there was lots of discussion prior to the AGM, which resulted in some substantial amendments to the resolutions being made in advance of the AGM.

#### Single Use Plastics and Plastic Packaging: CFUW Nepean

RESOLVED, That the Canadian Federation of University Women (CFUW) urge the Government of Canada, and the Provincial, Territorial, and Municipal Governments to implement Canada's Plastic Science Agenda (CaPSA) and, with the Canadian Council of Ministers of the Environment, to provide funding for the full implementation and follow-up of the Canadawide Action Plan on Zero Plastic Waste.

RESOLVED, That CFUW urge the Government of Canada, and the Provincial, Territorial, and Municipal Governments to expedite the ban on single-use plastics and to expand the ban to include all problematic and unnecessary non-recyclable plastics to prevent these items from entering the environment or waste management facilities.

RESOLVED, That CFUW urge the Government of Canada, and the Provincial, Territorial, and Municipal Governments to fully fund development of school curricula and promote programs to educate the public about the impacts of all forms of plastic pollution on wildlife, human health, and the environment. (CaPSA);

RESOLVED, That CFUW urge the Government of Canada and the Provincial, Territorial and Municipal Governments to provide research funding and incentives including start-up funding to decrease the environmental footprint of plastics, including improving their design and enabling value recovery (reuse, repair, remanufacturing, recycling, and composting) to support a circular economy for discarded plastics. (CaPSA)

#### "Right to Repair" for Large Household Appliances: CFUW Cape Breton

RESOLVED, That the Canadian Federation of University Women (CFUW) urge the Federal, Provincial, Territorial, and Municipal governments to create and implement "right to repair" legislation, including a minimum five-year warranty on parts and labour, making the repair of large household appliances used in Canada easier, reducing waste and greenhouse gas emissions, as well as creating local jobs.

#### Canada's Opioid Crisis: Montreal Lakeshore University Women's Club

RESOLVED, That the Canadian Federation of University Women urge the federal, provincial, territorial and municipal governments to work together to address Canada's opioid crisis, as outlined in the Government of Canada December 16, 2020 document, Federal Actions on Opioids to Date, by: 1. increasing the number of safe injection and overdose treatment sites and providing improved access; 2. expanding public awareness of a. addiction to prescription and street drugs, and b. protection under the 2017 Good Samaritan Drug Overdose Act amending the Controlled Drugs and Substances Act; 3. increasing awareness about the stigma of addiction and the resulting reluctance to seek help; 4. updating current prescription and treatment guidelines for pain management and/or opioid addiction; 5. improving access to harm reduction treatments, such as: a. easier access to Naloxone for emergency use, and b. Suboxone, and other detoxification treatment alternatives; 6. supporting and enhancing efforts to restrict the influx of illegal opioids and the tainted drug supply. RESOLVED, That the Canadian Federation of University Women urge the federal, provincial, territorial and municipal governments to work together in order to address Canada's opioid crisis by moving the focus of the opioid crisis from corrections to health care through, but not limited to the following: 1. working with multi-discipline stakeholders and professional health and security organizations to implement alternatives to criminal justice approaches, including evidence-based decriminalization of drugs for personal use;

2. working with stakeholders, including health practitioners and counsellors, on best practices in pain management and/or opioid addiction;

3. increasing support and psychosocial services for vulnerable people by increasing the number of trained professionals available to address the opioid crisis;

4. increasing and improving training of first responders, counsellors and public security personnel to better recognize and address addiction, and the associated stigma, by integrating such training into the core curriculum at post-secondary institutions and ongoing professional development;

5. establishing a cross-Canada electronic prescription drug registry.

Post-Pandemic Recovery for Women in Canada and Abroad: CFUW International Relations Committee

RESOLVED, That the Canadian Federation of University Women (CFUW) urge the Federal, Provincial, Territorial, and Municipal Governments to develop and fund a comprehensive Post-Pandemic(s) Socioeconomic Recovery Plan(s) including specific interventions to address the disparate effects of pandemics on the lives of women in Canada and abroad.

By-laws, motions, financials and everything but the resolutions:

There were some substantial changes made to the various motions, in particular the Moncton motion, which received little discussion prior to the AGM. (at least discussion to which members in general were privy).

Motions voted on at AGM are set out below.:

CFUW Oakville Proposed Bylaw Amendment: was approved with 90.6 in favour and 27.5 voting against, so the bylaw now reads as:

"Dues 13. Each club shall pay CFUW annual per capita dues based on its paid membership. If clubs choose to support GWI they shall pay GWI per capita dues, as determined by the CFUW board and based on the dues structure established by GWI."

CFUW AURORA-NEWMARKET AND CFUW MARKHAM-UNIONVILLE MOTION was approved with 81.3% voting in favour and 18.7 voting against, so dues are as follows:

CFUW per capita dues for clubs excluded from the GWI dues calculation (Opt-Out Clubs): is \$55.00.

For clubs included in the GWI dues calculation (Opt-in Clubs): \$55.00 plus the prevailing per capita GWI dues in Swiss francs multiplied by the Bank of Canada 26 Annual Average Exchange Rate published on the last business day of the preceding year; and That funds collected for GWI dues will be kept in a restricted fund; and That GWI dues will be paid from the restricted fund; and that in years when amount paid is less than the amount collected for payment of GWI dues, amounts will accrue in the restricted fund for payment to GWI dues in years when the amount owed exceeds the amount collected; and that clubs included in the GWI dues calculation will share equally, on a per capita basis, the additional costs if there is not enough in the restricted fund to cover the full cost of GWI dues.

MONCTON PROPOSAL Moved That CFUW pay all dues owing on the GWI invoice to be received in January 2022. (please note that as an opt out club we will not be paying GWI dues) 73.9 % voted in favour and 26.1 voted against.

#### **CFUW Ontario Council AGM**

CFUW Orillia was the host club for the Ontario Council AGM on Mary 14th and 15th. Lin F represented CFUW Brantford and was very impressed with how resilient and creative the organizers were in adapting the AGM from an in-person to a virtual event. The Keynote Speaker and Reception on the Friday night and the Business Meeting on the Saturday were effectively managed with 240 attendees registered throughout Ontario. This AGM was very costeffective and allowed more people to attend virtually than usually attend in person. The Orillia Club was very impressive in navigating the technology, setting the atmosphere for thought-provoking and social sessions, and even awarded 'door' prizes. The Keynote Speaker, Dr Wendy Cukier provided insights on what was necessary for Canada to achieve a positive economic recovery, particularly as it relates to women. The break-out rooms provided opportunities for sharing information about creative ways that clubs were adapting to the pandemic. The business portion on Saturday morning ran very smoothly. The St. Catharines resolution on Human Trafficking was passed. Ontario Council (OC) is in solid financial shape and their budget and reports also passed.

This year, for the first time, Advocacy Awards were presented to clubs that had done stellar work in areas such as Long-Term Care and Human Trafficking. OC also recognized member clubs celebrating significant milestones with a brief summary of the club's history and key initiatives over the years. Most notably, St Catharines celebrated their 100th Anniversary. Amendments to the CFUW Ontario Council Constitution and Bylaws were approved and may be viewed on the OC website.

Next year, the CFUW Ontario Council AGM will be hosted on May 13 and 14 by Kitchener-Waterloo who will also be celebrating their 100th Anniversary.

#### Update LTC Ad Hoc Advisory Committee, September 2021

The Ontario government is working behind the scenes on some recommendations moving forward. They are also in the process of revising the LTC Act (2010) which was called for in the Independent Commission recommendations. I do not know what is in it at this point. They are also building new LTC homes in various places and began doing so before the Independent Commission Report came out at the end of April. At present the Ontario government is prorogued until Oct 4<sup>th</sup> so not sure what will be happening in the meantime in regards to LTC.

With the federal election happening this month, Long-Term Care is an issue that the candidates have addressed. Specifically, they are talking about either more money or increased transfer payments to provinces.

CFUW Ontario Council is focusing their efforts on recruitment, training and increased wages for PSWs.

CARP Ottawa continues to plough ahead pushing for emotionbased care (transformative culture change) for all LTC homes. On Sept 15<sup>th</sup> there will be a webinar given by the Eden Alternative folks in Saskatoon and all collaborating organizations and LTC homes will be invited. CARP is also working on recommendations for election platforms (provincial and municipal). They have been meeting with reps from all parties. In addition, they have been con-

tacting influential people in Ontario to seek advice on how to make their advocacy efforts more effective. They are also talking to the Ontario Health Coalition, some RTOs in province, AdvantAge Ontario and Ontario LTC Association.

Three of our members have decided to withdraw from the committee this year: Lynn H, Tish J., and Brenda M. Those members remaining are Lin F. Sandra H. Betty Anne W. and myself. If you would like to join our small group, please let us know. Most of our efforts are done by email. Marg E., Chair

#### UPDATE FROM:

#### AD HOC COMMITTEE ON FUTURE DIRECTIONS 2020-22

Your Ad Hoc Committee is relieved to report that two concerns have been addressed by CFUW National regarding the organization's financial challenges:

CFUW Opt-In Clubs will be fully responsible for all costs related to GWI such that GWI will no longer be a drain on CFUW National's operating expenses and reserve funds.

For 2021-22 only, CFUW National will return to all Opt-Out Clubs the dollar amount that represents the dues normally paid to GWI. For CFUW Brantford, that amount is \$1,714.30, and will arrive in January 2022. Clubs are to determine what to do with the money. At our September 22nd General Meeting, your Executive has invited members to showcase any international not-for-profit organization that they support outside of CFUW. Following the meeting, there will be a vote taken via Survey Monkey to ask our members whether we should allocate the \$1,714.30 to the organizations showcased by our members or bank the money until 2022 -23 when CFUW National is expected to recommend to Opt-Out clubs what alternative international organizations would be appropriate to receive our dues.

The outstanding issue is the number one recommendation of the Mediation Working Group: "CFUW should update their Articles and Bylaws to remove all references to external organizations over whom CFUW does not have complete managerial authority and governance; specifically, Article 4."

It is disheartening that the Board has not implemented the recommendation of the Articles and Bylaws Committee, independent legal advice, the Mediation Working Group, the professional Mediator and Professor of Law, the Auditor, Accountants and the Attorney General's Office - Directorate for Not-for-Profit Corporations

Act. Their rationale is that introducing the opportunity to Opt-In/ Opt-out of paying GWI dues is an interim step and that there is too much division within and between clubs regarding this contentious issue.

**CONCLUSION**: Your Ad Hoc Committee has worked effectively with other clubs across Canada and with National and is pleased to have made an impact. We believe that CFUW is on better footing financially, and that they may be able to stand down from the amber alert in 2022-23.

**NEXT STEPS**: The Ad Hoc Committee will continue to work with CFUW National to keep abreast of the financials, GWI, the recommendations of the VP International and her Committee, and what Opt-Out Clubs are doing regarding the allocation of returned funds, and when Article 4 will be addressed.
