Ad Hoc Committee on Long Term Care Update

On December 6th the new LTC Homes Act 2021, received Royal Assent. "The Providing More Care, Protecting Seniors and Building More Beds Act, addressed both residents living in long-term care (LTC) and those in retirement homes (RH). The few changes that were made within LTC addressed:

- establishing in law the commitment to provide an average of four hours of direct care per resident per day by March 31, 2025, with increasing interim goals to increase care
- establishing new compliance and enforcement tools, including doubling the fines on the conviction of an offence
- strengthening the Residents' Bill of Rights to align with the Ontario
 Human Rights Code and recognizing the important and ongoing
 role caregivers play in resident health and well-being

Within the retirement homes those changes made were about:

- providing better quality care for residents, and better protection for those in unlicensed homes
- improving protection for residents against financial abuse
- strengthening the authority of the Retirement Homes Regulatory Authority (RHRA), to be a more effective regulator and administrator of the Retirement Homes Act, 2010.

What the Ontario government is doing is:

- investing \$4.9 billion over four years to support more than 27,000 new positions in long-term care, including personal support workers, registered nurses, and registered practical nurses.
- providing an additional \$72.3 million over three years to increase enforcement capacity including doubling the number of inspectors across the province by 2022–23.
- investing \$6.4 billion to deliver 30,000 net new long-term care beds by 2028 and about 28,000 upgraded long-term care beds across the province.

Since COVID was first detected in Ontario, <u>4,430 long-term care residents</u> have died after being infected, amounting to 44 per cent of the province's 10,036 COVID deaths. An Independent Commission was formed in 2020 which subsequently made 85 recommendations regarding long-term care in Ontario. The new LTC Act has addressed a very small portion of those recommendations. The real meat of this new LTC Act will lie in the Regulations which will now be revised. These Regulations will be developed over the next few months and will have a public consultation process in its development phase.

INTEREST GROUPS & ACTIVITIES


Interest Groups:

The group felt that the story opened our eyes to the desperation that drives people to try to escape to 'American Dirt' in the hope of safety and a decent life.



Thursday Night Book Club: Balzac and the Little Chinese

Seamstress by Dai Sijie



This very short book about two teen-age boys' experience of re-education in the remote countryside of Mao's Chinese Cultural Revolution, provided a wonderful backdrop from which to think about our cultural and economic relationships with China today. Through their theft of a suitcase of French classic

literature, they sought to make their isolation more bearable and used the books to impress the daughter of the local tailor. The symbolism of the violin and the alarm clock as bourgeois luxuries illustrated that no one (the village headman, the peasants, the boys, the former opium dealers) really accepted the limitations of Mao's communism.

Our conversation touched on how the Chinese political penchant for the long view over centuries has shaped their progress towards becoming a global economic power today. In this context, we reflected on how challenging it is to find common ground between Asian and North American socioeconomic cultures at a nation level, while at the same time many of us have cherished individual friendships that span diverse cultural differences.


General Meeting
