5. REPORTS CFUW BRANTFORD ANNUAL REPORTS 2022-23

5.1 PRESIDENT IN NAME

This has been a wonderful year for the Brantford club as we slowly return to the "new" normal. CFUW Brantford has welcomed new members, has been able to enjoy in-person events and attend hybrid General Meetings.

This past year brought back many of our in-person celebrations — the Blue Lake Picnic, the Seasonal Celebration and our annual meeting where we were wonderfully entertained with music. Our club is now 77 years young and going strong.

This year saw a move to hybrid general meetings which allowed those unable to attend in person to enjoy our meetings and the wonderful speakers we have heard this year. Hybrid meetings have been very handy when inclement weather has struck as we can simply move the meeting to Zoom instead of cancelling.

The executive meets by Zoom and this is working very well. As a club we are continuing with the President of the Month system which seems to be working very well.

Interest Groups are meeting again, and where in-person has not been possible, again Zoom has allowed members to keep connected with those in their respective interest groups.

This year, once again, saw our club members generously donating to our local women's shelter and the long-awaited return of our club's Trivia Night fundraiser for the Scholarship Fund was a great success.

5.2 ADVOCACY

While the Advocacy Committee did not operate in 2022-23 in a formal way, our members focused on educating themselves about local and global issues, used their expertise to advocate for change, and were involved in focusing on women's issues such as violence against women, pay equity, and childcare.

Our President in Name, Betsy Capitano, led our club's participation in the National resolutions process. Betsy's background as a lawyer was a great benefit, and we received a high level of appreciation from clubs initiating resolutions in 2022, stating that our club's feedback and recommendations helped them clarify and tighten their resolutions. Betsy is currently leading our review of the 2023 resolutions.

CFUW National and Ontario Council offered opportunities to participate in advocacy-related topics, including Zoom education, webinars, meetings, and petition-signing. Topics included climate control, development of the green belt, MAID, gun control, abortion, long term care, wage parity, concerns about privatization of education and health, to mention a few.

Our members have contributed generously over the years to the local women's shelter, Nova Vita, and continued our involvement this year through their *Hope for the Holidays* initiative.

Many of our members attended International Women's Day events, and supported other CFUW clubs with their initiatives to mark the day.

Our Interest Group, "World Awareness" met monthly by Zoom with the objective of broadening their understanding of local, national and international issues with focus on topics related to the political scene, health care, and long term care.

With in-person social gatherings now standard, our website has been rejigged to feature new posts over static information and this helps it aggregate higher for Google searches when people are looking for Brantford clubs. The Facebook feed works in a parallel way and has also benefited from increased photos of club activity.)
- 4. The Zoom meetings for Executive and General meetings, created and facilitated by Anne Martin. Individual Interest Group Zoom meetings were facilitated by Group chairs including Jean Ling for Creative Cookery, Kay Ruuska and Barb Melara, Roma Makkreel and Bev Golden, and Marsha Skrypuch for the various Book Groups, and Nora Fueten for World Awareness.
- 5. Outreach and Goodwill, managed by Gloria Smith and Leslie Leach, respectively.
- 6. Dropbox, managed by Dian Kuzyk for part of this CFUW year. She has passed the role on to Maria Timmons.

5.4 INTEREST GROUPS

Interest Groups continue to be an important part of belonging to CFUW with many members belonging to more than one group. It is a wonderful way to socialize and get to know other members of the club. During this past year there have been more in-person meetings as Covid became less of a concern. However, Zoom meetings have continued in many cases, either through preference, weather concerns or convenience, to name a few of the reasons.

The **Biking Group** met weekly from May until October, meeting for a ride around the Grand River Loop or on various trails in and around Brantford including nearby communities. Rides are approximately 20 km, at a senior pace, with flexible dates and times

The **Walking Group** met weekly all year round, at the Rotary Bike Park off Grand River Ave. in the winter and various trails in good weather. Members often meet after the walk for a social time at a local Tim Hortons.

The **Golf Group** met monthly at Fescue's Edge during the golf season, and sometimes as early as April for a round of nine holes followed by an enjoyable time afterwards on the deck.

There are **three book groups**: The **Monday Afternoon** Group met monthly, with meetings varying from Zoom to in-person over a late lunch at Symposium Café. This group discussed various books that they read in the past month. The **Monday and Thursday Evening Groups** met on a monthly basis, again with meetings varying from Zoom to in-person meetings at a member's home. Discussion was based on one book from a predetermined list made at a yearly planning meeting. In most cases, discussions are lively and very often veer off the actual book topic.

Bridge Group members chose to continue playing online monthly with two games, one at 1:00 followed by a quick break, then a second one at 2:15. By playing on line, they were able to talk to each other and discuss the various plays at the end of each hand.

Creative Cooking Group met monthly via Zoom on the third Wednesday other than the first meeting of the season when they met at Lin's house. Meetings consisted of recipe sharing as well as lively conversations.

Once Covid restrictions were lifted, the **Dining Out Group** became very active with flexible dates and times. They dined at the Twisted Lemon, Good Earth Winery, Langdon Hall, Gran Sasso, The Olde School, La Cantinella, Devlins and The Cambridge Mill, sharing great conversation and delicious meals.

Food with Thought Group met monthly on the second Thursday in various members' homes for pot luck dinners and conversation, both serious and entertaining.

This year, **The Daytrippers** were inactive because some locations were not able to host groups. However, plans are to have activities begin again in the fall.

The Games Group met twice a month, the second Thursday and the fourth Monday at 1:30 p.m. playing both new and old games. Games took place outdoors in good weather and indoors at members' homes in the colder weather.

The World Awareness group met monthly on Zoom on the third Monday at 9:30 a.m. discussing a wide range of topics including the world political scene, healthcare and long-term care, as well as other issues that impact members more directly. A great opportunity to get to know each other and to broaden understandings of current topics.

5.6 PROGRAM

The Program Committee this year was comprised of mostly new members, Colette Wilson, Bev Osborn, and Linda Tripp. However, we are grateful for those who went before us. They offered help and advice along the way so that we were able to bring some very interesting, talented, and inspirational speakers to our monthly general meetings. Plans are already in place for more great speakers starting in September along with two new members who have joined our Committee – Dian Kuzyk and Lynda Stamer.

September 2022

Jennifer Budd, a resident of Paris gave a truly beautiful presentation of her fibre art (not to be confused with fabric art). She described her work as Woolscapes, landscapes or flowers created with felted wool that look like paintings. She wove into her talk information about how the demand for wool has changed and how the industry has accommodated that change. Her work is now available in digital reproduction on cushion covers and other items.

October 2022

Member-Supported NGOs – four CFUW members presented an overview of international NGOs with whom they are connected. Each received an equal share of money that was allocated for international advocacy as part of our annual dues. **Bev Golden** represented **CUSO Int'l**, a Canadian organization she served with as a young woman and has supported since. CUSO was created in 1961 by a group of university graduates working to end poverty and inequality globally.

Lynda Stamer (on behalf of Barbara Mayo Melara) spoke about Amarok, a Canadian charity which operates in Bangladesh. Mothers are taught, and they in turn teach five children every day in "micro schools". Barbara visits Bangladesh, and supports the Libby Women's School named after her mother.

Evelyn Picketts shared information about **The Home of Hope** in Malawi. Founded in 1998, this home has nurtured hundreds of AIDS orphans aged infancy to the end of high school. Encouraged by Jane Glaves, formerly of Brantford, Evelyn has travelled, volunteered, and taught at the Home 13 times, bringing with her funds to purchase things like mosquito nets, school supplies and even a van.

Colette Wilson (on behalf of Joan Prior) told us about Canadian Nurses for Africa. This young Canadian NGO was founded in 2007 to provide free medical, preventative, and sustainable health care to communities in Africa, primarily in rural Kenya. Canadian nurses pay their own way each year to assess and then treat thousands of patients. Joan is only sorry she is not young enough now to participate directly.

November 2022

Human Trafficking — a blight on our society, was the topic this month and was brought into sharp focus by Hannah Blackburn, Police Officer with Brantford Police Services, and Shelly Prendergast, a Victim Support worker with Victim Services of Brant. The target of traffickers is mainly women and young girls, often very young. They shared statistics and real-life situations through stories and a power point. Our members expressed gratitude for their commitment as they work to gain the trust of affected persons and families so they can then refer them to appropriate community agencies, as well as their ongoing efforts to educate the public.

January 2023

Karen Burke gave an uplifting and fascinating presentation that wove together her love and knowledge of gospel music with her amazing family history which harkens back to the Underground Railway. Dr. Burke is Professor of Music at York University, co-founder and leader of the Juno-award winning Toronto Mass Choir, and the York University Gospel Choir; and is herself, a Harry Jerome Award winner. Karen also happens to have been raised in Brantford by parents who were highly respected for their contributions to Brantford's educational system and music culture.

February 2023

Dr. David McNeil is CEO of the Brant Community Healthcare System. Rather than cancel the meeting due to terrible weather, David rose to the occasion and gave his presentation via Zoom, which members deeply appreciated. He explained all the changes that have occurred over the last few years, as well as how the hospital is evolving to address the needs of our growing community. This included the re-development of the Emergency Department and a new hospital tower. During a lively Q and A Dr McNeil addressed a variety of issues related to the hospital and its future.

March 2023

Dana Church reminded us of the vital role that bumblebees and bees in general play in our world. Despite being such relatively small insects, they help keep nature in balance. She reaffirmed this fine balance throughout her informative slide presentation. She left us with a challenge to do our small part in the fight to reverse climate change, such as embracing a NO MOW MAY to allow bees and other insects access to flowers we consider weeds. We need to give up our notion of a perfect lawn and stop polluting the earth with more chemicals. It was a sobering yet inspirational presentation.

April 2023

Peggy Edwards is a retired consultant, writer on aging, and an activist for the rights of older people. Through her interactive presentation, she addressed questions like: What is ageism? How does it affect the well-being of people as they grow older? How has it affected us personally? She also discussed how lifelong learning and intergenerational solidarity can help deal with and combat ageism. We also had a few laughs as we looked at the intersection of ageism, sexism and humour.

May 2023

For the second year in a row, it was decided to provide musical entertainment instead of the usual key note speaker. The pandemic and weather have limited the number of inperson events, and our members were very grateful for the opportunity to 'optimize their social time' and enjoy musical talent. This year, **Dave Jensen** is the featured musical artist.

6. INITIATIVES

Our members donated \$1,850.00 to *Hope for the Holidays*. In addition, individual members and their families also support Nova Vita with monthly contributions, and with sponsoring a family over Christmas.

6.2 CFUW Brantford Trivia Night - February 2023

CFUW Brantford held its fourteenth annual Trivia Night on Wednesday, February 8th, 2023 at the Dunsdon Legion, 9 Tollgate Rd. in Brantford. Because of the pandemic, this event was the first since 2020 and was our most successful to date with 30 teams registered. The weather cooperated and, because of e-transfer, the registration went much more quickly and smoothly. The entry fee was \$25 per person (\$100 per team) and a charitable receipt for \$15 was given to each competitor. There was a cash bar throughout the evening and complimentary pizza and pop at the end. Participants commented very favourably on the questions! This year we provided paper copies of the questions which proved to be very popular. There were 10 rounds of 10 questions per round. After a play-off for first place, the top three teams were awarded cash prizes totaling \$240. 27 door prizes, generously donated by club members, were given out throughout the evening.

The organizing committee consisted of Lynn Haylock, Dian Kuzyk, Brenda Malvern, and Colette Wilson. They were responsible for booking the venue, promoting the event, deciding on questions, typing up question sheets, running off print materials, designing a poster, making up packages for teams, requesting and collecting prizes, registering teams, keeping records, running the event, writing out receipts, arranging for pizza, preparing a financial report, and sending out thank you letters to donors. Colette drew up the large scoresheets and posters were put up around town. This year, Patti Kunashko did the receipts and because the majority of prizes were donated by members, there were very few thank you letters sent out. Volunteers were Rhynda Bulson, Lynne Duncombe, Angela Huntjens, Karen Innes, Roma Makkreel, Suzanne Mitchell,

Joyce Morris, Barb Perry, Mieke Schroeder, Gloria Smith, Lynda Stamer, and Maria Timmons. They greeted competitors, set up the hall, collected and marked answer sheets, totalled and recorded team scores, sold tickets/books, handled the finances, helped distribute prizes and served pizza. A wine and cheese event was held at the home of Dian Kuzyk in appreciation and celebration on March 1.

A sincere thank you is, once again, extended to Domino's Pizza for the donation of the pizza. Thank you also to those who attended and to members who donated prizes and made financial contributions. Approximately 30 members were involved as organizers, volunteers or participants.

The "Heads or Tails" game was, as usual, great fun and was enjoyed by all. Trivia participants who wanted to be involved were invited to make a donation of at least a toonie to the Scholarship Fund. The last person left standing won a \$100 gift certificate to *The Keg*. Thank you to Ted McCleister and the staff of McCleister Funeral Home for their ongoing support. \$166.70 was collected. We also had a raffle for 27 draw prizes with tickets being sold for \$2 each or 3/\$5. This brought in \$359.25. For the 5th year, a Book Sale organized by Barb Perry added another \$258.75 to our coffers. Donations totaling \$420.00 were received. Once again, the Dunsdon Legion gave us a charitable rate of \$150 + HST for the use of the hall.

A profit of \$3,232.37 was realized which has been deposited into the Scholarship account.
