There were 34 members who attended our March General Meeting in person at Thorpe's Carriage House and 12 who attended remotely by Zoom. Anne M, Diane B and Maria T worked at improving the microphone system and tested it to ensure that people attending remotely could hear and be heard, and that the sound system was improved at Thorpe's Carriage House. We are moving in the right direction to offer hybrid meetings to our membership, and we have a way to go. As President of the month for March, I apologize to those who attended the March 27th General Meeting by Zoom. I did not ensure that your votes were counted for motions and your show of hands recorded in the polls we took regarding the Articles and Bylaws. I contacted each of the twelve attendees to apologize personally. Thanks to Penelope J who quickly pulled together the first draft of the Minutes of the March 27th General Meeting, I was also able to send our Zoom participants the draft Minutes and ask them to review the decisions and weigh in with their input. Based on their feedback, the decisions made at the meeting will stand. We will ensure that hybrid meetings are on the agenda for our Executive Meeting on April 10th and that we take steps to ensure that all votes are counted. We seem to do well with Zoom-only meetings, and with in-person-only meetings. Our goal is to make our hybrid meetings effective and enjoyable for all attendees. After our virtual meetings in January and February, it was delightful to socialize in person at Thorpe's Carriage House and catch up with one another.

Thanks to the creativity and resourcefulness of the Program Committee, we continue to have interesting speakers at our General Meetings. In March, thanks to Mieke S and her guest, Jennifer D, who facilitated interviews of three refugees — from Syria, Africa, and Ukraine — we learned about the refugee experience of leaving home, coming to Canada, as well as the benefits and challenges of establishing life here for themselves and their families. It was a sobering and inspiring program. On the business front, we reviewed the excellent work that Teddy B has done with the Nominations process (second year in a row that the roster of Executive roles has been filled two months ahead of time!), the plans that Bev G and the Banquet Committee has for this year's Banquet and AGM — and the surprising good news that this year's tickets are \$60 - \$5 less than last year's cost!! We voted to move our bank accounts from Tandia to BMO or another financial institution that offers

e-transfers to accounts like ours that require two signatures. We discussed our CFUW Brantford Articles and Bylaws 2024 and agreed to add a dissolution clause (a clause that we hope we never need!). Maria T presented the 2024-25 Budget that will be shared over the next two months and voted on at the AGM. Patti K. reviewed the good work that the Resolutions Committee did in reviewing National and OC resolutions - making recommendations that our members supported. Barb S reminded us that membership renewal will take place in April and May, and Roma M announced two new interest groups to consider joining next year: tennis and mahjong. Karen I advised that Award A information has been sent out to the high schools and we look forward to learning about the Scholarship Award A recipients in the next few months.

The April 24th General Meeting should be very interesting: a) The guest speaker is an educator who will share her experience relative to the challenges faced by people who identify as LBGTQ.

b) We will vote on the adoption of the CFUW Brantford Articles and Bylaws 2024 by Special Motion:

"Given that *CFUW Brantford Articles and Bylaws 2013* is over a decade old and that recommended updates span at least eight (8) years, it is moved that the aforementioned document be replaced with *CFUW Brantford Articles and Bylaws 2024.*" c) We will invest fifteen minutes to discuss the CFUW Scholarship Trust Constitution 2024 that will be voted on by Special Motion at the AGM.

There is a lot of good work happening in our club, a lot of inspiring and enjoyable activities in our interest groups, and much kindness and support in our community in general. We have much for which to be grateful. In particular, I would like to thank the Leadership Team. It has been a delight to be part of it this year. Many thanks to the individual members who reach out to express appreciation for the work that we do. It is important that you raise questions or concerns with the President of the Month, who will address the issue personally or put it on the Agenda for the next Executive Meeting. As I write this newsletter article, my back yard is a sea of blue. And poking their way up through the scilla are tulip, daffodil and hyacinth shoots, some of which are sprouting blooms and dancing in the sunshine. I love Spring and the sense of new life, longer daylight, and warmer temperatures. I hope this season finds you in good health and spirit. Happy Spring to all. Lin F.

But we enjoyed discussing Snow Road Station by Elizabeth Hay. In the winter of 2008, Lulu, a 62 year old actor, lands a dream role in a Samuel Beckett play. She has a limited time to learn it but she manages the first few performances



and then starts to flub her lines. From there her career and life begin to unravel. Acting has been central to Lulu's life. Out of work, humiliated, she escapes to a family wedding and

an old friend at Snow Road Station. She decides she is through with drama. She thinks she wants peace. She finds anything but...At the centre of it all is the friendship between Lulu and Nan. As the two women contemplate growing old, they surrender certain long-held dreams and confront the limits of the choices they've made and the messy feelings that kept them apart for decades. Snow Road Station is not so much a story with a plot. Rather it is a series of life relationships and changes – some harsh and imposed, others slowly emerging and evolving.

Several other characters, mostly men, share in these tangled relationships and we watch them as they emerge and evolve and settle.

The difficult work of making maple syrup is a central theme. The work itself is often where the intersection of characters and their conversations occur. Stone Road Station opens with a marriage and the promise of social cohesion. However, things quickly begin to fall apart: the nuptials are threatened, Lulu loses her place in the world. But the story closes with the establishment of new romantic relationships and the birth of a much-loved child — a child who, in many ways, restores Lulu to herself. Everyone gave this book a thumbs up – it is tender and insightful. Losses often open the way for new and wonderful opportunities at any age. Linda T.


